PRIVACY STATEMENT - Version May 2023

1. INTRODUCTION

This is the Privacy Statement of Just Deliver It Europe BV, having it's office at Stuwmeer 96, 3994 HK Houten, registered at the Dutch Chamber of Commerce under number 89656865, hereinafter referred to as: "JDITE". JDITE is a Management and Consultancy company that takes ownership and is committed to successful delivery of 'mission impossible' assignments. JDITE collects a variety of personal data as defined in the applicable legislation (Personal Data) necessary to provide such services.

This Privacy Statement provides information on the processing of personal data in the meaning of the GDPR, hereinafter referred to as: "Personal Data" in the JDITE services. This Privacy Statement may be modified over time. You are advised to regularly review the Privacy Statement for possible changes.

2. WHEN DOES THIS PRIVACY STATEMENT APPLY?

This Privacy Statement is applicable to the processing by JDITEE of all Personal Data with respect to JDITE services.

3. WHO IS RESPONSIBLE FOR YOUR PERSONAL DATA?

JDITE and/or its affiliated companies are the controller (verwerkingsverantwoordelijke) for the processing of your Personal Data. This Privacy Statement indicates what Personal Data are processed by JDITE and for what purpose, and to which persons or entities the data will or may be provided.

4. FOR WHICH PURPOSES DO WE PROCESS YOUR PERSONAL DATA?

4.1 For JDITE services as (to be) agreed in the contract between you and JDITE, including for the purpose to inform and communicate with you, either in the context of the agreement or in the context of marketing services.

(A) WHAT DOES THIS PURPOSE ENTAIL?

If you contact us or register at www.justdeliverit.nl we include the Personal Data you provide us in our database. Also, we will process your Personal Data to fulfil JDITE services. JDITE has a legitimate interest to process Personal Data. We will propose your Personal Data for JDITE services, including without limitation.

- 2. Request additional information to fulfil JDITE services;
- 3. Internal JDITE business purposes in the scope of preparation and realizing JDITE services and also like lead generation / acquisitions;

(B) ON WHAT LEGAL BASIS DO WE PROCESS PERSONAL DATA FOR THIS PURPOSE?

We process your Personal Data because it is necessary for the performance of the services agreed in the contract to which the Personal Data subject is, it is necessary for compliance with legal obligations and for our legitimate interests pursued by JDITE. JDITE is a Management and Consultancy company and collects a variety of Personal Data necessary to provide such services.

(C) WHICH PERSONAL DATA DO WE PROCESS FOR THIS PURPOSE?

For this purpose, we process your Personal Data such as your name, street address, telephone number and email address and other contact details as far as it is necessary in relation to the purposes for which they are processed.

(D) HOW LONG DO WE RETAIN YOUR PERSONAL DATA FOR THIS PURPOSE?

For this purpose, your Personal Data will be retained for as long as required and depending on local law.

5. WHO HAS ACCESS TO YOUR PERSONAL DATA?

5.1 Access to your Personal Data within JDITE

All JDITE employees directly involved in the JDITE services have access to your data but only to the extent necessary to fulfil their respective tasks.

5.2 Access to your Personal Data by third parties

JDITE works with a limited number of third parties, like a lawyer, that process your Personal Data in order to be able to deliver JDITE services. JDITE may share your Personal Data with these third parties who will process it exclusively for the purposes described in chapter 4. In other cases, your Personal Data will not be supplied to third parties, except when required by law.

6. HOW ARE YOUR PERSONAL DATA SECURED?

JDITE has taken adequate safeguards to ensure the confidentiality and security of your Personal Data. JDITE has implemented appropriate technical, physical and organisational measures to protect Personal Data against accidental or unlawful destruction or accidental loss, damage, alteration, unauthorised disclosure or access, and against all other forms of unlawful processing (including, but not limited to unnecessary collection) or further processing.
